

Three weeks later, could this become one more death or life-threatening hospitalization?

- 1. Required Masks will save lives. Virtually all scientific, medical, and public safety information points to the use of masks or cloth face coverings as one of four standard tools to avoid infection and potentially save lives. While this has become a very widespread "recommendation" in all 50 states, many jurisdictions, including the U.S. government and about 20 states do not require such use statewide for the public.
- 2. -NEW- President Biden's administration moved on day one (Jan. 20, 2021) to implement coast-to-coast mask programs, but state-based leadership and enforcement is still needed.
- 3. Evidence-Based Medical Science has been de-emphasized. A growing number of internationally recognized scientists and medical experts show that masks make a dramatic difference in avoiding further spread of infection of the COVID-19 virus. Learn about the latest medical science data.
- 4. Mandatory masks are in effect in many states, cities and counties. The attached report focuses on the locations and jurisdictions that have adopted **required use**, for broad or narrow situations.

Policies on Required Use of Masks to prevent the spread of COVID-19: An Updated Nationwide Review ¹

OVERVIEW: The use of cloth face coverings or face masks has been one of the central issues, and tools, in the global fight to prevent the spread of COVID-19. Since late March of 2020, this has become a simple, low cost or no-cost action that virtually any individual can take.

As updated in November, the CDC now officially <u>recommends use</u> of such masks, now reenforced and expanded by the incoming Biden Administration (Jan. 21, 2021). As widely agreed, masks can prevent person-to-person COVID infections and literally save lives in any local or neighborhood setting, worldwide. The device can be a simple manufactured or doit-yourself one, using age-old, low-tech cloth material (including multilayer cloth or if necessary, a temporary cotton bandana or scarf.) With commercially sewn or home-made face coverings now encouraged worldwide (often free or costing a few dollars), billions of people globally can protect themselves. ¹

-*NEW*- **THE BIDEN FEDERAL INITIATIVE.** Beginning Inauguration Day, January 20, 2021, President Biden has issued both binding requirements and expanded guidelines affecting broad use of face masks. The report states:

"Implement masking nationwide by working with governors, mayors, and the American people. The President has asked the American people to do what they do best: step up in a time of crisis and wear masks. He has issued an *Executive Order Protecting the Federal Workforce and Requiring Mask-wearing* which directs compliance with CDC guidance on masking and physical distancing;

- in federal buildings, on federal lands, and by federal employees and contractors.
- Additionally, the President will issue Executive Order Promoting COVID-19 Safety in Domestic and International Travel which directs applicable agencies take immediate action to require mask-wearing on <u>many airplanes, trains</u>, and certain <u>other forms of public transportation</u> in the United States.
- Develop options for expanding public health measures for domestic travel and cross-border land and sea travel;
- He has called on governors, public health officials, mayors, business leaders, and others to implement masking, physical distancing, and other CDC public measures to control COVID-19."

STATES AND LOCALS FIRST IN THE LEAD: In the U.S., as of mid-January 2021 there are now at least <u>45 states and</u>



<u>territories</u>, as well as local and regional jurisdictions, that have acted on the medically indicated need to make mask/face covering use a <u>mandatory</u>, <u>legal requirement</u>, *not* just a recommendation. Evolved over a 10-month period, about <u>35 states</u>' orders are broadly aimed at protecting individuals in public settings and/or employees in public-use buildings. Others are focused or limited to certain specified employees or professions. One calculation shows that by August about <u>285 million or 85 percent of the nation's population</u> were in states and/or local areas with such orders. ^v Of these, 251 million (or 75 percent) were covered by statewide orders.⁴ Another 34 million were counties and cities with mainly local mandatory orders. Exemptions by age and health, plus uncounted travelers, make actual totals vary.

This differences became more distinct and urgent with the phased reopening of businesses and federal, state and local orders allowing indoor dining and group gatherings. For these next phases, the broader, near-universal use of masks in "appropriate settings" is seen as a low-cost tool that supports community interaction and freedom of movement. Compared to lockdowns and "stay-at-home" orders, required masks, combined with required 6-foot social distancing and handwashing became the three tools that allow businesses and recreation to reopen more safely. More recently, some states have added enforcement and even fines for non-compliance.⁵

This report is a review of latest available data on states and other jurisdictions that have moved to increase the use of masks and cloth face coverings, especially describing those with mandatory or required uses. The lists below include links to sources and citations, but the document itself is not intended as legal or medical advice. Some mandatory use plans have pending expiration dates or may be rescinded due to opposition. Because all policies are subject to change, sometimes on short notice, readers should note listed dates and also rely on source web links to identify future updates.


STATES: Mandated Masks / Cloth Face Coverings in Public

RECENT CHANGES & NEWS: Federal Executive Order (Jan. 21, 2021) In Iowa (Nov. 17), North Dakota (Nov. 13), Utah (Nov. 14), and West Virginia (Nov. 17) governors each imposed a broad required use of masks order for the first time or expanded earlier limited requirements. North Dakota (Jan. 18) requirements expired.

No Masks to Pro-Masks: The recommendation of wearing masks in the U.S. was a dramatic, direct reversal of medical policy. Until February and early March 2020, both the WHO and CDC promulgated public announcements and cautions stating that civilians should NOT wear masks in public, and that masks do not protect the wearer. Then, in late March, government health experts, first at CDC¹⁹ and then WHO in April reversed that position and urged the use of masks by the general public.²⁰ The high-level, federal promotions of use of masks in the United States have been to "recommend" and "urge", rather than mandate or require such use. The federal CDC website includes <u>guidance and mask-making</u> <u>instructions</u>. A mid-April peer reviewed report²¹ analyzes the evolving conclusions and recommendations. On May 6, CNN posted a consumer-friendly <u>story</u> on Why Some People Won't wear masks.²² *CNN:* "In many ways the U.S. is uniquely vulnerable to COVID, with its large health disparities, high number of uninsured, decentralized response and widespread skepticism over public health guidance like mask wearing."

CDC Director Dr. Robert Redfield strengthens mask use

...masks are "the most important, powerful public health tool we have" in fighting the pandemic. He said universal mask use could bring the pandemic under control in a few months and said, "I might even go so far as to say that this face mask is more guaranteed to protect me against Covid than when I take a Covid vaccine."

Scientific Brief: Community Use of Cloth Masks Posted Nov. 10, 2020-

"The prevention benefit of masking is derived from the combination of source control and personal protection for the mask wearer..." Experimental and epidemiological data support community masking to reduce the spread of SARS-CoV-2. The prevention benefit of masking is derived from the combination of source control and personal protection for the mask wearer. The relationship between source control and personal protection is likely complementary and possibly synergistic, so that individual benefit increases with increasing community mask use.

Mask Requirements Rescinded. In response to opposition and protests, planned binding mask/face covering requirements were withdrawn, unenforced or deleted in some jurisdictions. Some examples:

- **Michigan's** Supreme Court on Oct. 2, struck down orders already in effect: *The governor did not have authority after April 30, 2020, to issue or renew any executive orders related to the Covid-19 pandemic,*" <u>the court wrote</u>. -*updated Oct.*-
- **Georgia's** governor "to mask mandates: I'll see you in court." <u>Legal battle</u> with Atlanta mayor Bottoms, July 2020.
- **Ohio:** Gov. DeWine said April 27 that face masks must be worn in stores but after some residents found the order "offensive," he dropped it, stating, "People were not going to accept the government telling them what to do."








Fig. 3. Droplet transmission through face masks. (A) Relative droplet transmission through the corresponding mask. Each solid data point represents the mean and standard deviation over 10 trials for the same mask, normalized to the control trial (no mask), and tested by one speaker. The hollow data points are the mean and standard deviations of the relative counts over four speakers. A plot with a logarithmic scale is shown in Supplementary Fig. S1. (B) The time evolution of the droplet count (left axis) is shown for representative examples, marked with the corresponding color in (A): No mask (green), Bandana (red), cotton mask (orange), and surgical (blue – not visible on this scale). The cumulative droplet count for these cases is also shown (right axis).
